## Zero Tolerance Policy for On Campus Kids After-School Enrichment

At On Campus Kids After-School Enrichment, we are committed to fostering an inclusive and respectful environment where every child can thrive. The following actions are strictly prohibited and will result in immediate disciplinary action, including potential removal from the program:

7. Weapons: Bringing any form of weapons, including but not limited to firearms, knives, or any object that can be used to cause harm, is strictly prohibited. Any student found in possession of a weapon will be immediately expelled, and legal authorities will be contacted.
